The following information is from Datix – the electronic incident management reporting system used by Waikato DHB, there are however limitations in the ability to extract concise details for the information you are seeking as many of the Datix fields are often not completed when information is logged. Please note logging incidents in Datix is voluntary and assaults vary from the use of bad language to violence.

Due to system limitations information like role held, gender, possible weapon information cannot be provided as in many cases this information does not exist we are refusing this part of your request pursuant to Section 18(e) of the Official Information Act 1982.

We do not hold record of any charges laid so subsequently we have transferred this part of your request to New Zealand Police as per section 14 of the Official Information Act 1982.
