It is important that STI notifications for syphilis, gonorrhoea, AIDS and HIV are made using the correct process. Please go to the STI surveillance web page for the appropriate notification forms and follow the relevant instructions (link below).

Notification of STIs must be made using the correct forms and using this process, as the Health Act requires that notification is made without giving identifying information of the patient.


PHU new Service Director starts January 20th
